Franklin Midy, Université du Québec à Montréal

***Haïti post-séisme : reconstruction nationale,
intégration régionale latino-caribéenne et
configuration d'un nouveau monde américain***

Noted Haitian-Québécois activist intellectual, Franklin Midy takes the opportunity of the 40th anniversary of the Canadian Association of Latin American and Caribbean Studies (CALACS) to engage the politics of post-quake reconstruction in Haiti, its significance for Caribbean-Latin American regional integration and the configuration of a new Americas. The talk will also serve to kick-off a special round-table on post-earthquake reconstruction in Haiti organized by the Canadian Association for Studies in International Development (CASID).

Franklin Midy is Associate Professor in the Department of Sociology at the University of Quebec at Montreal (UQAM), researcher with the Research Group on Latin American Political Imaginaries (GIPAL) and with the Research Laboratory on Social and Political Practices (LAREPPS), and co-ordinator of the Institute for Inter-university Cooperation with Haiti (ICIH). His areas of specialization include development and international aid, social movements and cultural practice, and Haitian society. Since 2004 his work has paid special attention to the history of Atlantic slavery, the creation of a creole Afro-American society in Saint-Domingue, and the formation of Haitian society.

Le Québécois d'origine haïtienne Franklin Midy, intellectuel et activiste renommé, saisi l'occasion du 40ème anniversaire de l'Association Canadienne des études Latino-américaines et caraïbes (ACELAC), pour ouvrir le débat sur les politiques de reconstruction en Haïti après le tremblement de terre, la signification de celui-ci pour l'intégration régionale Caraïbes-Amérique latine et la configuration d'une nouvelle Amérique. La communication marque le coup d'envoi d'une table-ronde sur la reconstruction en Haïti post-tremblement, organisée par L'association canadienne d'études du développement international (ACÉDI).

Franklin Midy est professeur associé au département de sociologie à l'Université du Québec à Montréal (UQAM), chercheur associé au Groupe de recherche sur les imaginaires politiques en Amérique Latine (GRIPAL) et au Laboratoire de recherche sur les politiques et les pratiques sociales (LAREPPS), et le coordonnateur de l'Institut de coopération interuniversitaire avec Haïti (ICIH). Ses champs

d'étude particuliers ont été : le développement et l'aide au développement international, les mouvements sociaux et l'action culturelle, la société haïtienne. Depuis 2004, ses travaux portent spécialement sur l'histoire de l'esclavage colonial atlantique, l'institution de la société créole afro-américaine à Saint-Domingue et la formation de la société haïtienne.

**Maxwell A. Cameron,
University of British Columbia**

Texts, Media, and Constituent Power: Latin America from Ancient to Modern Times

To mark the 40th anniversary of the Canadian Association of Latin American and Caribbean Studies (CALACS), Maxwell Cameron, one of Canada's leading thinkers on the Americas presents a provocative vision of the nature of power in Latin America across time.

Max Cameron is Professor of Political Science at the University of British Columbia. He has published on a wide

array of topics which include the North American Free Trade Agreement (NAFTA), the left in Latin America, the eradication of land mines, and the political turmoil in Peru before and after the Fujimori years. His forthcoming work deals with the challenges of democracy in the Andean region. Professor Cameron has been invited to give expert testimony to parliamentary committees considering Latin American issues, and is a regular commentator on hemispheric affairs in the media.

The lecture has been named in honour of the late Kurt Levy, a literary scholar at the University of Toronto who served as the founding president of the Canadian Association of Latin American and Caribbean Studies.

Pour marquer le 40ème anniversaire de l' Association Canadienne des Études Latino-américaines et Caraïbéennes (CALACS), Maxwell Cameron, un des penseurs canadiens renommés sur la question des Amériques, présente une vision provocatrice de la nature du pouvoir en Amérique latine à travers l'histoire.

Le professeur Cameron a publié sur un grand nombre de sujets, dont la zone de libre échange Nord américaine (NAFTA), la gauche en Amérique latine, l'éradication des mines anti-personnelles, et la politique vertigineuse au Pérou avant l'ère Fujimori. Ses travaux futurs portent sur les défis de la démocratie dans les Andes. Le professeur Cameron a été invité à donner des expertises à des comités parlementaires sur des questions latino-américaines et il est régulièrement commentateur des questions hémisphériques dans les médias.

Sa conférence est dédiée à la mémoire du regretté Kurt Levy, chercheur spécialiste de littératures à l'Université de Toronto, Président-fondateur de l'Association Canadienne des études latino-américaines et caraïbes.

Para conmemorar el cuadragésimo aniversario de la Asociación canadiense de estudios latinoamericanos y del Caribe (ACELC), Maxwell Cameron, uno de los pensadores líderes de las Américas presenta una visión provocativa de la naturaleza del poder en Latinoamérica a través del tiempo.

El profesor Cameron ha publicado sobre una gran variedad de temas que incluyen el Tratado de Libre Comercio (TLC), la izquierda en Latinoamérica, la erradicación de las minas antipersonales, y la agitación política antes y después de los años de Fujimori. Su próximo libro trata acerca de los retos de la democracia en la región andina. El profesor Cameron ha sido invitado para presentar su experto testimonio en comités parlamentarios sobre asuntos latinoamericanos, y es comentarista asiduo acerca del hemisferio en los medios masivos de comunicación.

Kurt Levy, un crítico literario de la Universidad de Toronto quien sirvió como presidente fundador de la Asociación canadiense de estudios latinoamericanos y del Caribe.

Para celebrar o 40º aniversário da Associação Canadense de Estudos Latino-Americanos e do Caribe (ACELAC), Maxwell Cameron, um dos mais eminentes pensadores sobre as Américas no Canadá, apresenta uma abordagem instigante da natureza do poder na América Latina ao longo dos séculos.

O professor Cameron publicou inúmeros tópicos que abrangem o Tratado Norte-Americano de Livre Comércio (NAFTA), a esquerda na América Latina, a erradicação de minas terrestres, e a turbulência no Peru, antes e depois da era Fujimoro. Seu próximo trabalho trata dos problemas da democracia na região andina. O Professor Cameron foi convidado para dar um testemunho abalizado junto a comitês parlamentares que tratam das questões latino-americanas, e é comentarista assíduo na imprensa sobre assuntos do hemisfério.

O título da palestra é em homenagem a Kurt Levy, falecido estudioso literário da Universidade de Toronto, fundador e presidente da Associação Canadense de Estudos Latino-Americanos e do Caribe.
